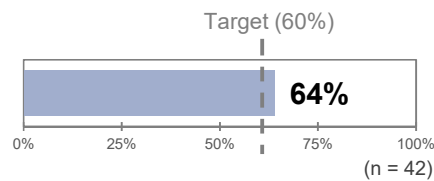

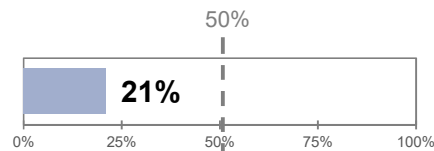

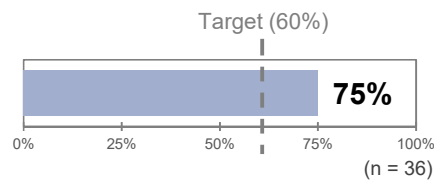

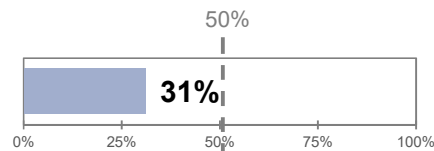

Percent of Most Positive Responses**

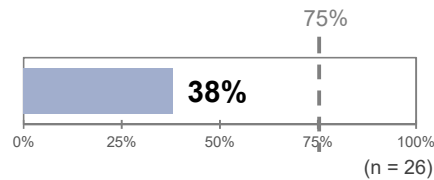
Student Survey Participation Rate: 86%
