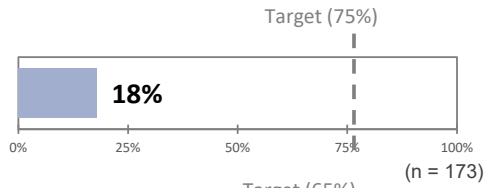

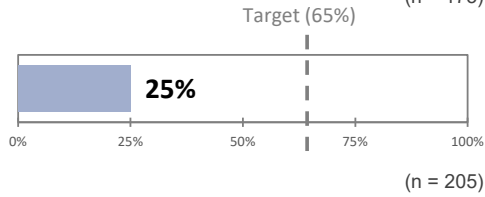

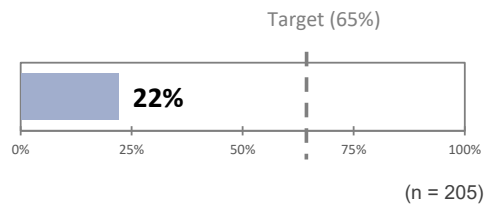

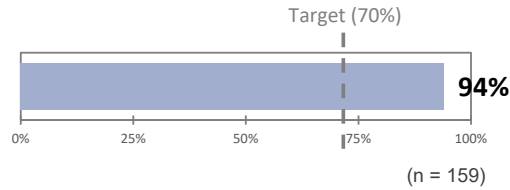

Distribution by Attendance Band

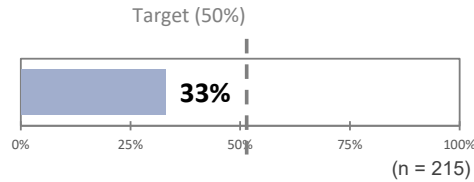

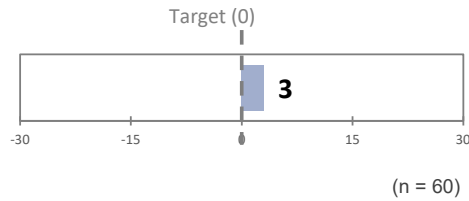

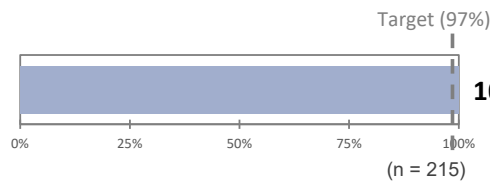

Average Change in Student Attendance Rate



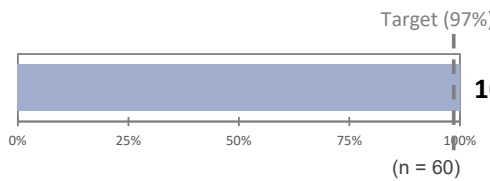

Percent of Students Reducing OSS

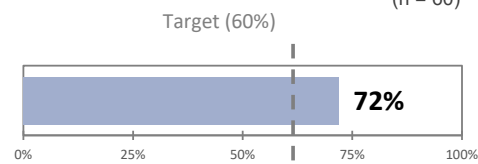

Student Survey Participation Rate: 36%

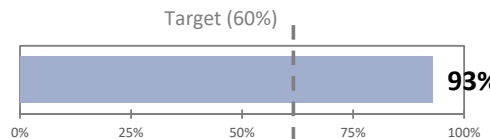
